

2022/23 End of Production Year timeline

The 2022/23 Production Year spans from 1 April 2022 – 31 March 2023. As stated in the NZECS System Rules, all transactions associated with the 22/23 Production Year must be completed by the 30^{th} of April 2023. For the successful closing of the Production Year in the Registry, a few important processes must be first completed.

With the understanding that some of the processes take time for System Users (Registrants and Participants) to complete and for the Certified Energy team to process, we have suggested the following fall of dates in this document. For requests that are received by these dates, we can guarantee that they will be processed in time for the successful completion of the transactions.

- 31st March 2023 5:00 pm NZT is the last day to register Registrant and Participant accounts, and request registration of Production Devices,
- 14th April 2023 5:00 pm NZT is the last day to submit Energy User registration requests, upload Energy User consumption data, and submit embedded generator production volumes,
- 27th April 2023 5:00 pm NZT is the last day to submit requests that will require NZECS admin support/review, and
- Between 28th of April till 30th of April 2023 11:59 pm NZT, the System User (Registrants/ Participants) can still perform issuance, transfer, and redemption in the Registry, however, we do not guarantee that the NZECS admin will provide any support.

In the event that requests are submitted after the recommended dates, we will do our best to accommodate the requests, but we cannot guarantee that they will be processed in time to complete the transactions for the 2022/23 Production Year. This will depend on the volume of requests we receive, and the level of support that the request requires in order to be successfully processed.
