



A Quick Guide to New Zealand Energy Certificates (NZ-ECs)

BraveTrace New Zealand Energy Certificates (NZ-ECs) are New Zealand's premier green product, widely adopted across Aotearoa. NZ-ECs enable energy users to prove that they own the renewable attributes of the generation they choose to support, while also generating extra revenue for renewable producers. NZ-ECs allow immediate reportable emissions' reduction and accelerate the renewable transition.

Report your Scope 2 emissions as zero.

NZ-ECs enable you to confidently report your electricity associated GHG emissions as zero, in accordance with leading international accounting standards (GHG Protocol Scope 2 Guidance, ISO 14064-1:2018). NZ-ECs are recognised and accepted by global partners such as CDP, SBTi, RE100, BCorp and Climate Impact Partners.

Reduce your climate-related risks.

Securing NZ-ECs helps you mitigate climate-related risks such as overseas market access, government policies, banking regulations, consumer shifting preferences, etc. By tracking and removing your renewable attributes from the Residual Supply Mix, BraveTrace prevents double-counting, and any double-claiming risks, and incentivises non NZ-EC users to act by increasing the carbon intensity of the Residual Supply Factor.

Make traceable and verifiable claims.

By choosing to consume renewable energy, and tracing it on BraveTrace's NZECS registry, you can make clear statements about the type of electricity you support, and confidently claim that every megawatt-hour (MWh) of certified electricity you consume is matched with a MWh produced from a verified renewable generator.

Drive New Zealand renewable future.
